Newsletters are published on the YRDSB or school website for sharing and promoting student achievements and/or school activities and events to the school community. Information published is accessible to any member of the public with access to the internet.</p>		

<p><b><u>YRDSB/School Social Media Accounts</u></b></p> <p>The YRDSB and school may feature your child’s achievements and/or participation in school activities and events on YRDSB or school-managed social media accounts. These social media platforms include but are not limited to Twitter, LinkedIn, and Instagram. Posts are made for the purpose of sharing and promoting student achievements and/or school activities and events. Information published is accessible to any member of the public with access to the internet.</p> <p>If your child’s classroom teacher will be sharing images, student work, or student information through a classroom social media account or other digital tools, you will receive a separate consent request.</p>		
<p><b><u>External Media Organizations</u></b></p> <p>The public media (print and electronic) may be present at certain school activities or events to showcase and promote student achievements or participation in extracurricular activities. The public media may interview, photograph, or digitally record your child (such as audio, video, or photo) for news articles to be printed or broadcast on newspapers, public television, radio, and online websites including social media platforms.</p>
